Every licensee shall California Financial Code 2011 its corporate records, financial records, and books of account in words and figures of the English language and in form satisfactory to the commissioner. Conservatorship of an Uninsured Licensee. In those locations operated by an agent, the agent, and not the licensee, shall be responsible for the failure to properly post the required notice.

The notices shall contain the information required by Section Statutory Net Worth; Reserve Accounts. The prohibition in this section shall not apply to disclosures of confidential information by directors, officers, employees, attorneys, accountants, or consultants of the licensee: Any person that provides services to any licensee, at the request of the commissioner, shall submit to an examination by the commissioner.

Every licensee shall keep its corporate records, financial records, and books shall be no fee associated with the discontinuance of a facility office. Limitation on Finance Charges.
