Prohibitive laws concerning persons, their acts or property, and those which have for their object public order, public policy and good customs shall not be rendered ineffective by laws or judgments promulgated, or by determinations or conventions agreed upon in a foreign country. If he disappeared after the age of seventy-five years, an absence of five years shall be sufficient in order that his succession may be opened.
